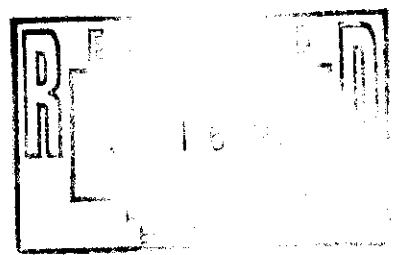

DECLARATION OF PRIVATE ROADS

KNOW ALL MEN BY THESE PRESENT: THAT ROBERT P. DRAKE, TRUSTEE, THE OWNERS OF ALL PROPERTY SHOWN ON THE PLAT TITLED DALTON WOODS AND RECORDED IN PLAT BOOK 5 AT PAGES 160-163 OF THE PUBLIC RECORDS OF MARION COUNTY, FLORIDA, DO HEREBY DECLARE TO ALL FUTURE OWNERS OF PROPERTY CONTAINED IN SAID SUBDIVISION THAT THE STREET RIGHT-OF-WAY AND DRAINAGE FACILITIES DESIGNATED ON SAID SUBDIVISION PLAT SHALL BE PRIVATE PROPERTY SUBJECT HOWEVER TO A PERPETUAL RIGHT OF EASEMENT FOR INGRESS AND EGRESS BY SANITATION, POSTAL, FIRE, LAW ENFORCEMENT AND EMERGENCY MEDICAL SERVICE VEHICLES AND THEIR PERSONNEL PROVIDING SERVICES TO THE SUBDIVISION. NEITHER THE EASEMENTS HEREIN GRANTED NOR THE LIMITATIONS HEREIN MADE SHALL CONSTITUTE A DEDICATION TO THE GENERAL PUBLIC OR MARION COUNTY AND NO OBLIGATION IS IMPOSED UPON THE COUNTY OR ANY OTHER PUBLIC BODY FOR IMPROVEMENT OR MAINTENANCE OF SUCH PRIVATE RIGHTS-OF-WAY OR DRAINAGE EASEMENTS.

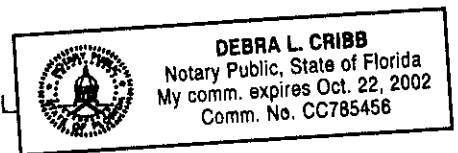
